CPAC Priorities For 2025-26

Dr. Ericka O. Erickson, CPAC Strategy & Policy Manager organized participants to join a discussion group of each CPAC workgroup/committee. Workgroups/committees reviewed accomplishments from 2024-25 and began discussing potential goals and direction for the workgroup/committee in 2025-26 based on the last CPAC Strategic Plan.

In addition to discussing priorities and goals for each CPAC workgroup and committee, Members discussed the importance of using CPAC's collective voice to take a stand and make official statements about current issues (e.g. poor treatment of immigrant families in the U.S., protecting school children from ICE).

Closing Reflections

Question: If we look back a year from now, what will make you feel proud of CPAC's work?

- Meaningful and intentional actionable items being met.
- CPAC advocates on crucial local ECE issues and is solution driven.
- Seeing a diverse group and working together to serve the most vulnerable children.
- Expanded access to free/reduced cost ECE for more families.
- UPK mixed delivery is aligned with the state.
- Networking and relationship building that created community and accomplished things.
- Seeing more action than talk (clear call to actions)
- Workgroup and committee goals being put into action and completed.
- We get a detailed budget for the Baby Prop C reserve.
- More resolutions to vote to full council from committees or members. We are advising the advising council to the Mayor, BOS, BOE.
- Educate people ahead of time on issues and take a stand.
- Be a strong advocate of some crucial ECE issues, solution driven.
- Revisit structure of meetings, hard to be generative. How to use this precious time when we are together and how to have these conversations?
- Diverse people working together for children. Ones who need it the most.
